An incorporator is one of the corporation's initial shareholders. Both individuals and other corporations may be incorporators. Shareholders are the owners of a corporation, though they do not have direct access to corporate assets. Upon dissolution of an incorporated company, shareholders receive a share of the leftover assets. By voting in shareholders' meetings, shareholders may effect changes to the company, including adding or removing directors and officers, or instituting policy changes. Shareholders may also serve as directors and officers. **Please complete applicable sections.**
